### 5a. Town Plan

Town Plan working group have invited Phil Wignall to represent UTP on this group. PW does
not wish to be involved due to time pressures. Meeting queried legal status of the outcome
of the Plan, parameters and funding. Not opposed to taking part, but felt more details were
required before nominating. ACTION DC to circulate initial minutes to see if they answer
these questions. Further discuss at February meeting

### 5b. Section 106 funding plan.

- Meeting expressed its dismay at the lack of support given by UTC over their proposal to use
  this funding stream to provide some paid admin support for event planning. In spite of
  comments made at the meeting and elsewhere, volunteer fatigue is very real, and not
  helped by the expressed attitude of UTC
- UTP aware that this linked to Sainsbury development, which now looks unlikely, but were disappointed with the UTC outcome in principle
- Possibility that this proposal be re- presented to UTC in 6 months. An opportunity to reconsider!
- Section 106 to be kept on the agenda in order to receive updates from RCC as appropriate.
